- Discount is now Cost Plus Zero (OPIS Wholesale) pricing at *all TA/Petro company store locations*
 - *There are a small number of franchise locations with a slightly lower discount, contact us for questions*
- OPIS Wholesale pricing is the reference used to determine fuel supplement pay in your TSPA
 - This pricing is also used to determine FXG pricing for fuel at it's pumps
 - REL TA Petro pricing now effectively matches FXG pricing
- The REL card can be used at all FXG fueling locations, as well as all fuel locations currently approved on T-Chek
- All transactional data automatically migrates to FXG for IFTA fuel tax reporting and fuel supplement pay

➤ Uses existing card platform

- Migrates data automatically to FXG
- No manual receipt collection/turn in
- No change to fuel supplement or IFTA – transaction data flows to both settlement AND fuel tax for IFTA reporting
- No additional fees – fee structure remains identical to current program

➤ Requires participant to obtain “new” Tchek card

- REL works with TSP to replace – 1 or 2 days
- Old card is active until new card is used
- No manual activation of new card

➤ New card functions exactly like old card

- Works at all locations including FXG sites
- Maintains existing discounts at NON TA locations
- **Adds REL TA/Petro discount of Cost Plus Zero pricing to card at MOST locations**
 - SOME franchise locations have slightly different discounts, please contact us directly for information
- ****Please note – with this discounted pricing, TA/Petro only offers standard points which may affect your drivers' incentive program. Please call us for further details**

➤ Process is extremely simple

- Requires truck number, CDAS number, entity name, and terminal location to send cards
- Self enrollment available through our website
- New cards sent to terminal usually within 1-2 days

- Once we receive your request, you will receive an email from: notifications@zohosign.com (Check Junk Mail too)
 - Email is an electronic signature packet (one page for each truck)
 - Sign pages electronically and submit
 - REL will order new cards that should arrive 1-2 days after signatures completed

Discount now at OPIS wholesale!



- Program open to all FXG TSP's
- No additional contract to sign
 - Requires a one-page acknowledgement of program with REL sent electronically
- Requires “new” Tchek card
 - Enrollment completed by REL, signed by TSP
 - TSP receives new cards within a few days, hands new cards to drivers and destroys old cards
- Migrates data automatically to FXG
 - NO MANUAL RECEIPTS REQUIRED
 - Fuel supplement pay
 - IFTA fuel transaction reporting
- Card used exactly like old card
 - Can be used at FXG fuel locations at their price
 - Keeps all other discounts currently in place – but note the REL TA/Petro discount only includes standard points
 - Can be used at any currently approved external fuel solution
 - May be used for DEF, oil, or any other product existing card is used for today including fleet net road calls
 - Settlement deducted weekly exactly like today
- **NEW CARD APPLIES THE REL FUEL DISCOUNT OF OPIS WHOLESALE AT MOST TA/PETRO'S IN U.S.**
